#### Editorial March 2014

Hi team; there is always good news and bad news. Unfortunately the bid /proposal we put before the MAAA land bureau was not approved. We did everything we could and included all the current criteria that were quoted at the Aug 2013 land bureau meeting. At the Nov 2013 presidents' conference in Melbourne the proposal was moved, seconded and passed. A short time later the NSWFFS made an offer on the land selected and we thought we were on our way. Little did we know we were lambs to the slaughter?

A short time later we were advised that our offer must be withdrawn and the proposed purchase was to be investigated by a review committee of three members selected by the MAAA president, because a number of state presidents withdrew their support for the proposal after they had voted for it. The review committee was given six weeks to present their report. How naive were we? The alarm bells should have rung loud and clear.

However we had examined previous proposals and we thought were way ahead. All information was to be channeled through the secretary. At no time during the report period was there a teleconference between the review committee and the NSWFFS. We did get a series of questions late in Feb and we suggested that the review committee had not read the proposal. We answered their questions in a fairly pointed way but they were eventually disregarded and not included as an annex to the report. The report was eventually published with 24 hours reference to the NSWFFS at the end of week 7. At the start of week 8 additional comment were added to the report.

I must clarify something here. I believe review group were given an impossible task. They were provided with terms of reference by the president of the MAAA which was vague and did not include the criteria laid down by the land bureau in Aug 13. The review group then started to examine all the processes included in the purchase of land. It did not fully focus on the proposal and they made up their own criteria. The terms of reference were later referred to as Rules of Engagement by the President MAAA.

It is interesting to note that the recommendation not to purchase the field was stated in the first paragraph of their recommendations and everything after that supported that recommendation. Paragraphs 8-10 of the recommendation by the working group even suggested that the proposal by the NSWFFS was "fanciful, poorly constructed, squandering time, fanciful or grandiose visions, the act of an irresponsible organization unfit to administer the interest of a large Australia wide membership base". What a wonderful selection of words for a review committee to make! I did refer the matter for a legal opinion on the Monday before the conference but it was too late for any action.

Needless to say we were slaughtered! Only one state supported our proposal (TMAA) and I say thanks for that support. It was interesting to note that CLAS did not field a representative only an apology. MAS have always opposed our proposal and as such are in my opinion the only honest voter on the panel. I don't agree with him because our proposal included RC, so in effect he was penalising his own members. Not to worry we will continue to find another way to get our field.

The good news; did you hear the joke?



#### A National Free Flight Field.

Since the NSWFFS proposal to purchase the 700 acre Wyalong property known as "Kelso" was rejected by the MAAA, an idea to raise the money privately has been put forward. The idea is to form a company to buy the property, offering 400 shares @ \$1,000 each. This would raise the \$350,000 asking price, pay the Stamp Duty and other statutory fees and charges, leaving some capital for development of facilities.

NSWFFS could perhaps buy 40 shares. Other individuals and organizations could also be approached to purchase multiple shares. Even the MAAA could be approached to purchase shares in this venture.

Since the property is back on the market and the NSWFFS have a complete Development Approval from the Bland Shire Council, for Model Aircraft use over the property, it would make sense to capitalise on the good work done and money spent so far.

A time limit of 6 weeks is anticipated to gauge expressions of interest and actual commitment to purchase shares.

#### Buttferflys & Js at Richmond. Tahn Stowe

The Hannaford Clan, Matt, Josh, Tim, Sam and Donna Gray made 15 maxes, with 5 P30s, to reach the fly off.

They were so busy winding, launching and retrieving that it was difficult to tell whose model was whose.

While these lightweight silent aircraft climbed and circled above before gently gliding to earth, Terry, Roy and Tahn were hurling high pitched screaming F1J's. All three made 3 two minute maxes to also reach the fly off.

The scene was set for the showdown and because of the lack of timekeepers and spare winders, the J's were allowed to fly first.

With a simultaneous launch and 3 motors peaking at 30,000 revs each, the J's were soon at the top of their climb trajectories and gliding nicely against the blue sky.

Now it was time for the P30's. With the exception of Josh (Nationals P30 runner up) who broke a motor, they were all wound and launched like a squadron of colorful butterflies.

The air was not especially kind and none managed to make the 3 minute max, all landing on the turf a few seconds apart, much to the delight of all who witnessed the spectacle.

Josh did finally get into the air however the scrutineers deemed he had launched outside the 10 minute fly off window, and his flight was ineligible.

The three J flyers decided not to attempt 4 minutes as the wind was gaining strength and heading for the Hawkesbury.

With 'sheep stations" on the line this contest will be resolved at some time in the future, perhaps at Narrandera in April.

#### Additional Information

- 1. WORLD CUP EVENTS are flown from a flight line in seven one hour rounds. Please assist by volunteering to time keep.
- 2. Flyoffs will be organized after the event (start time, CD and timekeepers) but held the following morning. Durations for F1A, B & C, G, H, and J will be 10 minutes. For other events unlimited (conditions permitting).
- 3. P-30 and OzD are flown on the last day and therefore cannot have flyoffs the next morning. You may make a longer 1<sup>st</sup> round flight (up to 10 minutes) as flyoff insurance in case more than one flyer maxes out. If you want your 1<sup>st</sup> flight to be considered as a flyoff it must be launched before 0900.
- 4. OPEN EVENTS are 3 flights to a 3 min. max with no rounds and one unlimited flyoff the next day.
- 5. Gliders otherwise conforming to the F1H/A1 rules will be allowed in F1H at any weight provided they are fitted with a non-latchable towhook.
- 6. Old style F1J/Class 1 Power models restricted to a plain bearing motors less than 1 cc and no moving surfaces except DT will be allowed an 8 second motor run in F1J (bring out your Mini Weavers and ½ A Vikings)
- 7. P-30 is 3 flights to a 120 sec. max. No rounds. One unlimited fly-off (which for this event will be the 1<sup>st</sup> flight).
- 8. COMBINED % OPEN is 3 flights (no rounds). Score is the percentage of the max for that class. HLG and CLG are allowed but are only allowed 3 flights i.e. no discards. Two attempts are permitted for each flight (a 20 second attempt rule applies).
- 9. VINTAGE Glider, Rubber and Power will be flown as a combined event. You may enter more than one class. Champ of champ points will include all entries. Note the new vintage cut-off date of 1956. VINTAGE classes get bonus points (2 per year pre 1956) as per MAAA rules 2009
- 10. HLG/CLG/DLG are combined, not separate events. All flights from the box marked by 4 cones.
- 11. Oz Diesel (1.5cc plain bearing diesel, no VIT, AR etc., see FFDU2002/3), 10 sec motor run, 5 x 2 min flights. One unlimited fly-off (which for this event will be the 1<sup>st</sup> flight).
- 12. Radio Dethermalization (RDT) is allowed in all events.
- 13. PLACEGETTERS in AFFS events may be processed. There will be spot checks and check timekeeping on the field.
- 14. All Competitors must be in possession of a current MAAA/FAI licence.
- 15. AFFS Annual General Meeting. See notice at CDs table for venue and time. Please forward agenda items, nominations etc. to the secretary, Tahn Stowe by April 1.
- 16. The Presentation Dinner will be on the evening of Thursday May 1. Location will most likely be the Morundah Pub (bus from Narrandera). Cost will be about \$35. We need to know numbers in advance so please make your bookings for the dinner and pay with your entry.
- 17. Motorized retrieval is not allowed (pedal and electric bicycle retrieval is). We are not permitted motorized retrieval on the Department of Defence land (Field 1) and for Field 2, although motorized retrieval has been allowed in the past, we have had problems with the dust raised by cars obscuring models and blanketing the flight line.
- 18. Smoking on the field is not allowed. If you smoke in a car the doors have to be closed.
- 19. Sunrise at Narrandera on April 25 is at 06:43. Sunset 17:32.
